## Parent's/ Guardian's Statement

Please enclose a check for the applicable deposit(s); or, if submitting this form electronically, please send the deposit separately within 14 days. I hereby agree that this deposit will be forfeited if withdrawal from any session occurs after April 30, 2024. Furthermore, I am aware of the camp's policy regarding tobacco, vaping products, alcohol, illicit drugs, computers, and cell phones; and I agree to swiftly withdraw my camper from the camp without any refund of the camp fee if she is/they are found to possess or be using any such substance or item while at Road's End Farm. As I am also aware that the camp program at Road's End Farm is neither designed nor staffed to deal with campers with behavioral problems, I agree to remove my camper from the camp's premises immediately and to forego any return of the unused portion of the camp fee should she/they be involved in bullying, or any other aggressive or inappropriate behavior. I acknowledge that my camper will be supervised much of each day and during scheduled activities; however, as the freedom to fully experience farm life has been a hallmark of the Camp program for its value in encouraging campers to be more responsible and confident, I accept that there will be times when my camper will be on her/their own with other camp friends and that she/they must follow the Camp's well-defined rules governing unsupervised time at the Farm. I have also read the Camper's Statement below and I concur that campers wishing to attend the camp should sign it and conduct themselves accordingly. To ensure that Road's End Farm will be in compliance with the statutes of the State of New Hampshire, I shall make certain that a fully completed Road's End Farm Health Certificate signed by my camper's physician will accompany her/them to the camp. I also agree that my camper will comply with all Road's End Farm requirements related to COVID-19. Inasmuch as the consequences of environmental factors, including climate change with its resultant weather extremes, may one day preclude the safe or full operation of the Camp program at Road's End Farm, I accept that under such circumstances the program may be scaled back or sessions cancelled with no recourse for affected families other than the return of any unearned camp fee. Lastly, I agree to provide a completed and fully signed Road's End Farm Enrollment Questionnaire when I remit the balance of the camp fee, which is due 30 days prior to the start of my camper's session.

I, the undersigned, am aware that Road's End Farm Horsemanship Camp functions very much like a big family living on a working horse farm where daily chores and work on improvement projects are shared by all, and where everyone is considerate of one another. Furthermore, I understand that Road's End Farm is not a summer resort for campers seeking to lounge around all the time and not contribute, nor is it a place for individuals inclined toward bullying or any other aggressive or inappropriate behavior. In keeping with my above knowledge of what Road's End Farm is and what it is not, I agree that my daily riding privileges at the camp and my participation in other activities are to be earned by me based upon my behavior and respect for others, my willingness to do a fair share of the camp's work, and my ability to keep my personal belongings neat. I also understand that alcohol, tobacco, vaping products, illicit drugs, are forbidden at the Farm; moreover, I agree to leave the camp immediately without refund of my camp fee if I am found possessing or using any of them. Similarly, I acknowledge that cell phones are not permitted on the Farm. I also agree to comply with all Road's End Farm requirements related to COVID-19. Lastly, by signing this statement I am not relinquishing my right to have a wonderful, fun-filled camp stay at Road's End Farm, but rather I am acknowledging my responsibility to contribute to the well-being and enjoyment of my fellow campers so that wonderful, fun-filled camp stays can be had by all.
