## GUIDELINES FOR ARRIVING AT ROAD'S END FARM

- **Arrive at the Farm between 10:00am and 2:00pm** on your camper's first day of camp. Please do not arrive before 10:00am as that is very disruptive to the camp's staff as they go about their morning chores and preparations to welcome you to the camp.
- As a number of campers will be arriving on Sunday of each changeover weekend, you would be well-advised to **plan on spending a couple of hours or more at the camp**. Getting moved in, seeing the nurse, and speaking with the camp director can be time-consuming activities, especially if a number of families happen to arrive right at the same time or without paperwork.
- If rain is forecast on your camper's arrival day, **be sure to bring an umbrella** or two as the camp is not well suited to wet weather and large crowds.
- As missing or incomplete paperwork is the main culprit in slowing the process down for everyone, be sure to have completed every form on the [camp form checklist](#) prior to your arrival.
- Make certain **all clothing, footwear, and tack that you are planning to bring to Road's End Farm have been thoroughly washed and disinfected** to prevent our horses from catching contagion from horses at other equestrian establishments that you have frequented where exposure to equine diseases is much greater than for our highly susceptible herd, sequestered as they are at the end of a little traveled road. Please do not bring grooming items with you to the camp.
- Before your camper heads off to Road's End Farm, make sure she/they are absolutely free of head lice and nits as she/they will be screened for them by the camp nurse on her/their arrival at the camp and will be promptly refused admission if she/they has signs of either. For that reason, **please do not move your camper's belongings into their Dorm or Cape until she has had a lice check with the camp nurse**. Campers who have lice on arrival will be permitted to return when they are free from lice and nits, which will be verified by a re-screening with our camp nurse.
- **Bring with you your [camper's Road's End Farm Health Certificate](#) signed by her physician and by at least one parent or guardian**. If the physician has signed a standard physical form for her instead, please make sure that it accompanies the Road's End Farm health certificate.
- **Bring with you a photocopy of your camper's official and up-to-date immunization record**.
- If your camper will be bringing an asthma inhaler or an Epi-Pen to the camp, be sure either is accompanied with a New Hampshire authorization form completed and signed by your daughter's physician. Please contact Sarah if you need one of these forms.
- **Bring with you a photocopy of both sides of your family medical insurance identification card** or of your camper's temporary travel and vacation accident and illness policy, whichever applies.
- Ensure that you **test your camper for COVID-19 within two days of arrival**. The nurse will confirm when you meet with her on the first day of camp.
- If you have not already sent in a completed [Enrollment Questionnaire](#) and a check for your camp fee balance, please bring the questionnaire and a check or cash for the balance of the camp fee due as reflected in the email to which this form is attached. Do not include any spending money in the amount of this check as that goes to a separate account.
- Lastly, as cell phones and mobile internet devices are a lot like head lice in diminishing everyone's camp experience, please make sure none are left behind in your daughter's luggage to start an itch that might entice an otherwise upstanding girl to break a hard and fast rule prohibiting their use at the Farm.
